## Personal data that we process

Bon Scotch processes your personal data when you use our contact form because you then provide it to us.

## Special and / or sensitive personal data that we process

Our website does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However, we cannot check if a visitor is older than 16. We encourage parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. ## For what purpose and on what basis we process personal data

Bon Scotch processes your personal data for the following purposes:

To answer the questions you asked us through our contact form.

## Automated decision-making

Bon Scotch makes no decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without a person (for example an employee of Bon Scotch) sitting in between.

## How long we store personal data

Bon Scotch does not store your personal data for longer than is strictly necessary to realize the purposes for which your data is collected. We use the following retention periods for the following personal data:

- First and / or last name
- E-mail address
- Address data
- Phone number
- IP address (to prevent spam)

Personal data> Storage period: As long as necessary, up to one year> Reason: To call or e-mail you if necessary to be able to carry out our services

## Sharing personal data with third parties

Bon Scotch will only provide third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

## Cookies, or similar techniques, that we use

Bon Scotch does not use cookies or similar techniques.

## View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Bon Scotch and you have the right to data portability. This means that you can submit a request to us to send the personal information we have in our computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to [avg@bonscotch.nl](mailto:avg@bonscotch.nl).

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (Machine Readable Zone, the strip with numbers at the bottom of the passport), passport number and Social Security Number (SSN) black in this copy. This is to protect your privacy. We respond as quickly as possible, but within four weeks, at your request.
